<ul style="list-style-type: none"> <li>The Non-Resident membership category is available to existing Active members, former members or non-residents who <b>do not own</b> property within a 65 mile radius of the Club, <b>***OR***</b> Current Active members who have legal residence outside of Pennsylvania and are able to show proof of non-Pennsylvania residency. May own property in Pennsylvania. Must have been a member for 10 years or more.</li> <li>The Non-Resident membership is a full privilege membership providing access to the golf course, sports complex and clubhouse.</li> <li>Rounds of golf may be used by member, spouse or children through age 24.</li> </ul>	<ul style="list-style-type: none"> <li>Junior members are age 16-21</li> <li>Junior members are not eligible to play in Club golf events</li> <li>Junior members not possessing a driver's license are not permitted to drive golf carts</li> <li>Unaccompanied play restrictions for Junior members, when approved by the golf shop, are:                             <ul style="list-style-type: none"> <li>8:00am - Noon and after 2:00 pm on Tuesday and Friday</li> <li>After 5:00pm on Wednesday</li> <li>After 2:00pm on Thursday, Saturday, Sunday and holidays</li> </ul> </li> </ul> <p>Note: This is a golf membership only and does not include the Sports Complex</p>	<ul style="list-style-type: none"> <li>Corporate Dining membership entitles up to six designees of one company access to the Clubhouse or any other areas included in club social events.</li> <li>Corporate Dining members have no Sports Complex or golf privileges and are considered guests and are subject to all guest restrictions and guidelines.</li> </ul>
